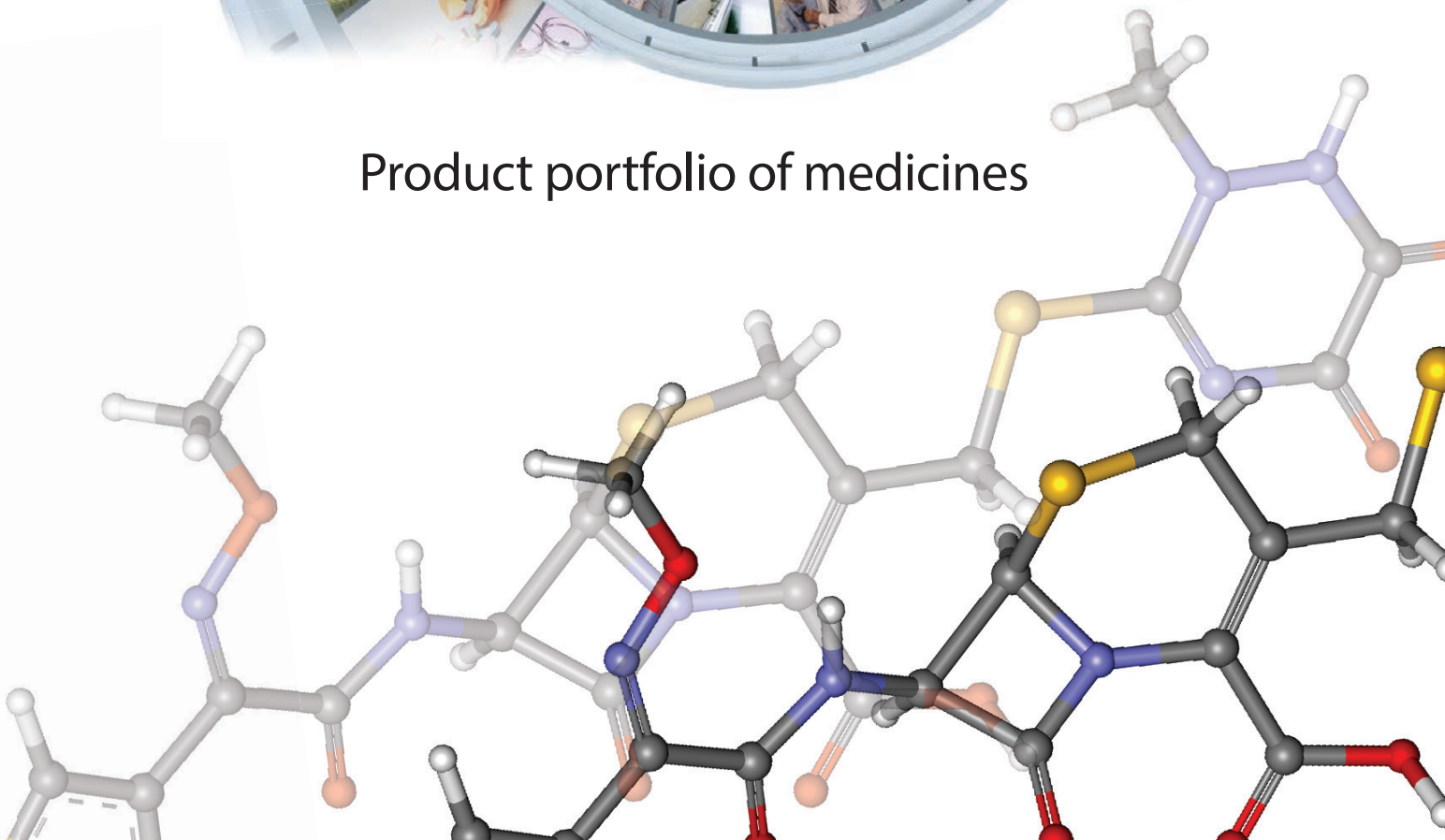

MANUFACTURING ACTIVITIES

Medicines are manufactured in Rajasthan, India at Ananta Medicare's own plants. The total area of the plants is about 30,000 sq.m.

The first plant of Ananta Medicare is to be launched in October 2018. It will manufacture cephalosporin antibiotics in oral and parenteral forms.

The production line capacity is 15,000 vials/hour.

The second plant will have been launched by 2020. Its specialization will be lyophilized and liquid injections.

Manufacturing and quality control systems of these plants have been designed in compliance with the PIC/S GMP requirements such as MHRA, FDA, etc.

The company's work is aimed at

- manufacturing of quality products;
- health gain of different population groups with different income and needs.
