



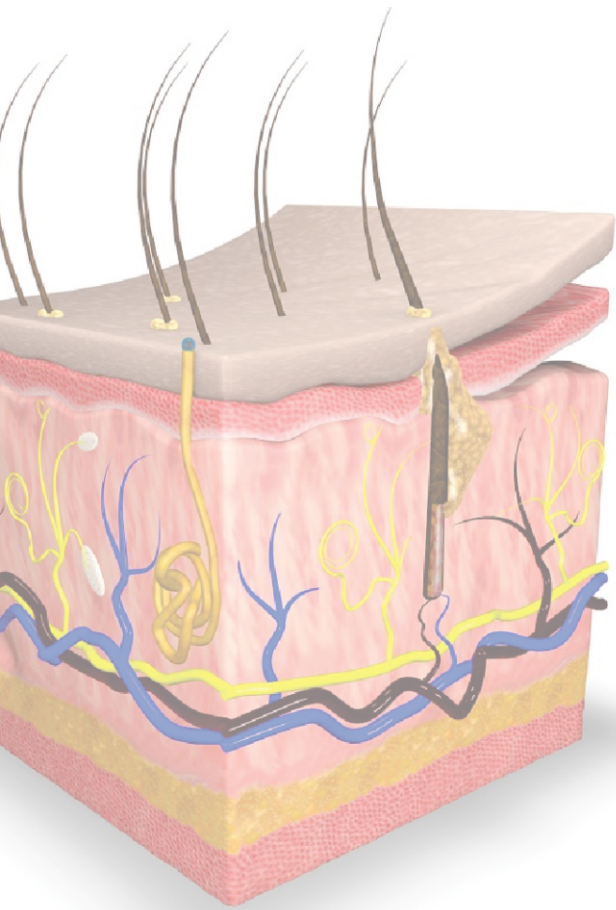

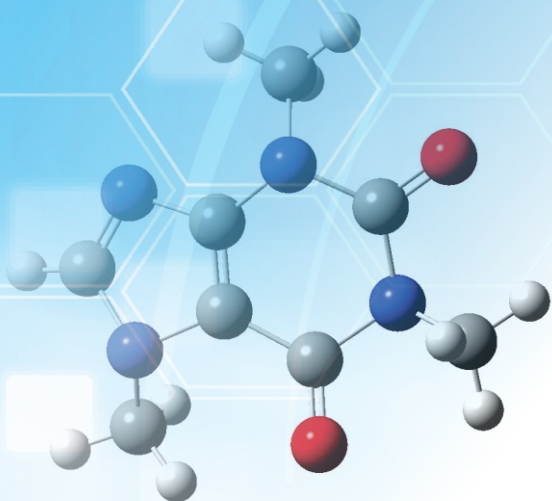
## CLINICAL TRIALS

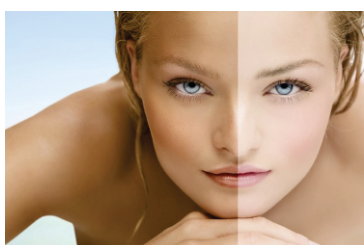


### Moisturisation Testing

- Corneometer, Dermal Phase Meter and Tewameter assessments for humectants and emollients.
- Substantiates claims such as: Moisturising, Combats dehydration, Moisturises for up x hours, Improves Skin's Natural Barrier and more.

### Anti-Wrinkle Assessments

- We offer profilometry assays to measure qualitative and quantitative assessments of rhytide reduction.
- Substantiates: Anti-wrinkle, Wrinkle Defence, Reduces Wrinkles by x% and more.



### Skin Tone / Lightening

- Chromameter technology analyses pre and post-product skin tone.
- Substantiates : Improves Luminosity, Reduces Uneven Pigmentation, Encourages Even Skin Tone, Reduces Hyperpigmentation, Reduces Appearance of Age Spots.

### Skin Elasticity / Skin Firmness

- Cutometer or Dermal Torque Meter measures the rate of initial and release extensibility of the skin pre and post-treatments.
- Substantiates claims such as: Firming, Improves Skin Elasticity and more.

### SPF Tests (UVB)

Tests for all around the world. COLIPA, ISO:24444, FDA and more. We also conduct water, sand and sweat-resistance tests.

### UVA Tests

Substantiates UVA protection through the COLIPA method.

## MORE SPECIFIC SAFETY TESTS



### Human Eye Tests :

Direct and Non-Instillation

Tests for any products that could come into contact with the eye cavity.

### Substantiates claims :

No Tears, Ophthalmologically Tested,  
Ophthalmologist Approved, Kind to Eyes.



### Comedogenicity Tests

Tests for the production of comedones (blackheads)

Can substantiate the claims: Non-Comedogenic,

"Prevents the appearance of blackheads", "Unclogs pores"

### Phototoxicity & Photosensitisation Tests

Tests the potential for a product to elicit a reaction under UV exposure.

Substantiates the claims: Non-phototoxic, Non-photosensitive.



### Oral Soft Tissue Assessments

A small section for mouth washes, toothpaste and other oral products.

## Skin Tone / Skin Lightening Assessment

This efficacy assessment measures qualitative and quantitative changes in skin pigmentation allowing you to claim differences in skin tone on-pack.

### Claims Substantiated :

Improves luminosity, Reduces uneven pigmentation, Encourages even skin tone, Improves skin tone, Reduces hyperpigmentation, Reduces the appearance of age spots.

## Chromameter Technology and Macro Photo Assessment

This measures chromaticity, tristimulus values, colour difference and correlated colour temperature.



## Moisturisation Tests



These efficacy tests prove that your formulation provides moisturisation and other benefits to the skin and allows you to claim as such on-pack.

- Corneometer / Dermal Phase Meter (Humectant Products)
- Tewameter (TEWL – Emollient Products)

### Claims Substantiated :

- Moisturising, Combats dehydration, Moisturises for up to 'X' hours, Soothes and softens skin, Improves skin's natural barrier and more.

**Briefly, what you can expect :**

## Corneometer / Dermal Phase Meter Assessment :

- Dermal Phase Meter used for US studies or if requested.
- Both instruments are capacitous instruments pressed against the skin which measure the hydration of the stratum corneum. They do this by evaluating the Dielectric Constant of the skin as a ratio to water (constant of 1) as differences in hydration will manifest within this measurement. The value produced is an arbitrary Corneometer / Dermal Phase Meter value.

## Tewameter (TEWL) Assessments :

- Measure the Trans-Epidermal Water Loss – the amount of water lost across the epidermis – which makes it possible to measure the invisible, yet steady evaporation of water through the epidermis.



## HAIR CARE STUDIES

These efficacy studies look at the various characteristics of hair growth and hair renewal and the benefits that products give to hair.

### Briefly, what you can expect

- For one of our most standard tests, this is one of the most individual assessments that we provide as every hair care differs in subject number, assessment type and study length.
- We use a mixture of expert Vidal Sassoon qualified visual assessors and instrumental evaluations to assess anything characteristic of the hair.
- A few hair characteristics that we can test: Anti-dandruff, Strengthening, Conditioning/Detangling, Volumising, Shine / Oiliness, Bounce, Smell, Feel, Frizz, Colour Retention: you name it, we can test it.
- All staff are fully trained in dandruff grading, psoriasis and seb derm grading. At the salon, we can offer our clients the latest in clinical assessments for their hair care products. We specialise in half-head and whole-head dandruff studies, user tests and home use studies. We can also perform clinical trials with your styling products, colour products or shampoo and conditioning products.
- Our volunteer panel includes many ethnic races and we can recruit subjects of both sexes who are happy to participate in all the studies we perform. We also have a trained panel of 50 male and 50 female subjects who we use on a monthly basis who are trained to assess products for their odour, texture, efficacy and acceptability.
- We also perform numerous depilatory studies for hair removal creams, epilators and waxing.



## 96 HOUR PATCH TESTS

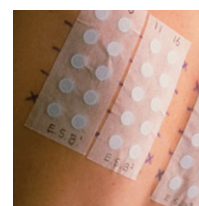
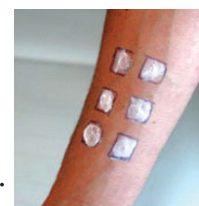
This safety test proves that your formulation is safe for use in an *in vivo* situation. This is specifically for a product that would definitely cause irritation if full or semi-occluded.

**Claims Substantiated :** Dermatologically Tested, Clinically Approved, Safe for Skin.

### Briefly, what you can expect

#### 1, 2, 3 or 4 Open Application Tests

- This test is performed on products with a high flash point and/or with a high alcohol content where full or semi-occlusion under patches would cause severe skin irritation. With Open Application Testing, the alcohol is allowed to flash off leaving the active on the site.
