Scigeniq QMS is cloud-based and fully compliant with all regulatory requirements for the electronic management of quality documents and processes.

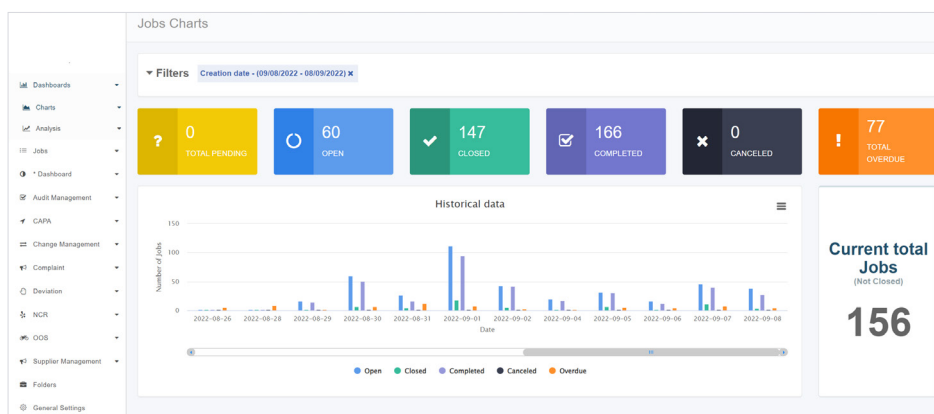

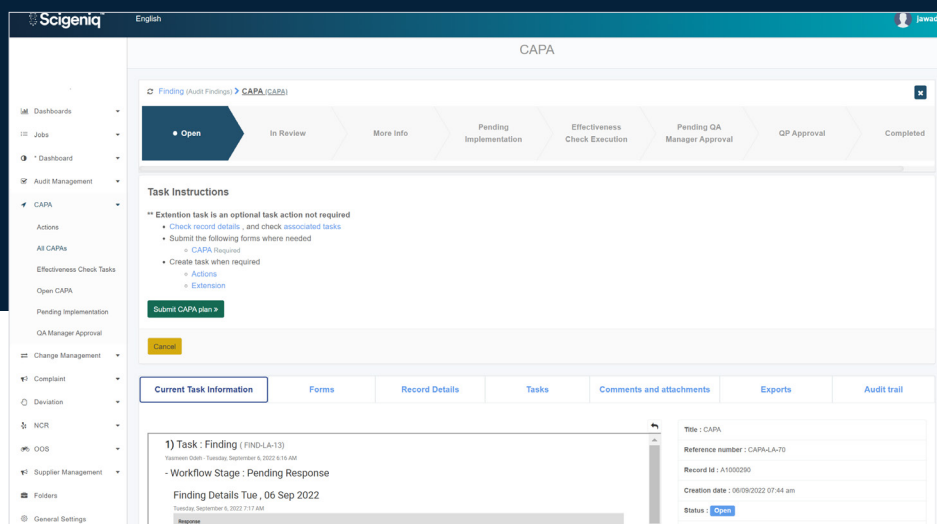
