Each spraying applies 10 mg of lidocaine. It is not necessary to dry the site before application.

To be used in the mucous membranes and provides effective superficial anaesthesia for approximately 10 to 15 minutes.

Anaesthetic action onset usually begins within 1-3 minutes depending on the site where it is applied.

## Posology

AREA	RECOMMENDED DOSE (mg)
Nasal procedures, e.g. puncture of the maxillary sinus.	20 - 60
Oral and dental procedures, e.g. prior to injection.	20 - 200
Oropharyngeal procedures, e.g. gastrointestinal endoscopy.	20 - 200
Respiratory tract procedures, e.g. introduction of instruments and catheters.	50 - 400
Procedures in the larynx, trachea and bronchi.	50 - 200
Obstetric procedures, e.g. vaginal delivery, suture of the mucosae and cervical biopsies.	50 - 200

## Precautions for use

Dose recommendations must be considered as guidance, the experience of the doctor and the knowledge of the general condition of the patient being essential for the determination of the dose.

Use with caution in patients with wounds or traumatised mucosa in the application site, due to increased systemic absorption.

The use in the oropharynx may interfere with swallowing, thus increasing the danger of aspiration and biting trauma.

Avoid contact with the eyes.
